Frequently Asked Questions

What will my donation be used for?

Donations contribute to a wide range of purchases aimed at improving staff and patient welfare. They may also be used to purchase specialist equipment or build new facilities, e.g. Bobby Moore Cancer Unit.

Doesn't the government fund the Trust?

We receive government funding for the treatment of patients – donations **will not** be used for this purpose. However, donations give us an opportunity to improve the environment for our patients and staff.

How do I know where my money is going to be used?

When donating, you can choose whether your gift is for the general purpose of the whole Trust, for a particular speciality, for a ward, department or for a specific purpose.

The donation will be deposited in an appropriate fund and may only be used for the charitable purposes defined by law and the object of the charity.

The funds retain individual identity but are registered as a single charity with the Charity Commission - Stockport NHS Foundation Trust Charitable Fund (No. 1048661)
